During the course of the EGM, I tried to raise questions pertaining to these issues. However I was told repeatedly to "shut up and sit down" by a very aggressive and petulant Dr Clews. He clearly did not want me or 1000 , the only member of public there, to raise legitimate questions. Dr Clews' demeanour was threatening, intimidatory and made both 1000 and me, feel very uncomfortable.	I simply do not recognize this account. The meeting was arranged with full compliance with covid restrictions. There was an agreed agenda for the meeting which was solely to sign off two official documents. This person [C1] had several outbursts each displaying a marked lack of self-control in public. He was called to order three times and was told to sit down and be quiet. He and [C2] then chanted "You're so rude" at the chairman. After the meeting was closed a discussion was proposed by the chairman to better understand why he needed to rant. He accepted and it very soon became apparent			
At the end of the EGM, Dr Clews who was clearly in a very distressed state, advanced towards me, within less than one metre distance with a contorted expression, waved paperwork at me	 we were in for a repeat tantrum, Both episodes were witnessed by the full PC, the clerk and the County Councillor. Yet he [C1] simply cites [[C2] as witness. Why? There were five others present. I sought permission to reveal their email addresses to the MO to corroborate my statements. This was done. Further, on the same date, I witnessed Dr Clews jump out of his seat and charge towards [C1], frantically waving his handful of papers, shouting aggressively and invading the 1 metre space set by the Covid 19 guidelines. This was intimidating and again, hardly the behaviour of a Chairman. I was appalled by his actions. I was the only witness to this as both Cllr P Taaffe and Cllr C Rickhards were engaged in a private discussion a few feet away, however I did record what I heard on my phone. The other two Cllrs and the Clerk had chosen to leave the meeting many minutes earlier!	This description is also at variance with 5 witness statements and my account.				

EGM on The Green Sambourne - Monitoring Officer's comments and conclusions

...five witnesses appear to blame C1 for the disruption of the meeting. They use phrases of C1 like "repeatedly interrupted"..."ranting" and "really quite aggressive and very unpleasant"..."more and more aggressive and agitated"..."complete loss of self-control" and "tantrum".

C1 can hardly be surprised ...that he was repeatedly asked and, eventually, told to sit down. ...both councillors raised their voices during the EGM but that it was initiated by C1's behaviour rather than that of ClIr Clews.

Given the date of Cllr Clews' complaint against C1 it seems at least possible that there may have been a "tit-for-tat" element in C1's later complaint against him.

Conclusion: no breach.
